First FarmBank is excited to announce our first ever Hometown Christmas Coloring Contest for children ages 12 and under!

Contest Rules and Details:

No purchase or payment of any kind required to enter or win. Purchasing additional products and services does not improve chances of winning.

Each participant will receive a free activity book. Activity books are available on a first come, first served basis.

To enter: The entry period begins Saturday, Dec. 1, 2018 at 8:30 a.m. and Saturday, Dec. 15, 2018 at 12:00 p.m. Entries delivered on Saturdays must be done through our drive-thru. 127 22nd Street location in Greeley is not open for Saturday hours. Neither the children nor their parents and/or guardians need be First FarmBank customers to enter or win. Entries must be dropped off to any First FarmBank branch to enter. Please do not put the artist's name on the front of the picture. Entry must be the selected coloring page for the child's age group. No other pictures will be allowed.

Age categories: The coloring contest will be split into three age divisions: 6 years of age and under, 7 - 9 years of age and 10 - 12 years old. Children may use crayons, colored pencils or markers. Please no paint of any kind.

Eligibility: The Contest is open to legal U.S. residents 12 years of age or younger. Children of employees of First FarmBank and members of the household of such individuals are not eligible to win but may submit an entry and receive an activity book. Void where prohibited or restricted by law. The Contest is subject to all applicable federal, state and local laws, regulations and taxes. By participating, entrant agrees to abide and be bound by the Official Drawing Rules and to accept the decision of First FarmBank as final in all respects.

Prizes: Prize winners will be determined based on Facebook votes (likes) from finalist entries. A committee of First FarmBank employees will select ten finalist entries from each age division for public voting. Prizes include: The entrant with the most votes in each category will receive either four (4) movie tickets to a local movie theatre or a gift card to the theatre in the equal amount. Winners may make no substitution/transfer of prize. To keep voting fair, we will not post names on Facebook for voting. We kindly ask that you not mention names in the comments or shares.

Prize restrictions: Prizes are non-transferable. Federal, state and local taxes, and any expenses relating to the acceptance and use of the prize not specified, are the sole responsibility of the winner. Limit one prize per person.

Odds: Odds of being selected as a Finalist will depend on the total number of eligible entries received at any First FarmBank location.
